YOU EXPRESSLY ACKNOWLEDGE THAT YOU HAVE READ THIS NOTICE AND UNDERSTAND THE RIGHTS, OBLIGATIONS, TERMS AND CONDITIONS SET FORTH HEREIN. PRIVACY POLICY

INFORMATION PRACTICES

Phi Sigma Sigma Foundation (referred to as "Phi Sigma Sigma Foundation," "Foundation" or "we/our/us") understands that security and privacy are important issues for users of our web site and other electronic services ("SITE"). We are committed to protecting and respecting your privacy. We endeavor to comply with all applicable laws on privacy protection and personal information security. That is why we maintain the following standards to help protect information that personally identifies you. By using the SITE and providing us with your personally identifiable information, you consent to our use of such information as described in this Privacy Policy.

Our Privacy Policy, together with any additional terms and conditions that contain supplementary information in connection with particular services you are using, outlines our privacy practices regarding the collection, use and safeguard of your personal information through our websites, devices, applications and any services, both online and offline we provide (hereinafter referred to as "SITE"), along with whom we may share or disclose the collected information. WHAT INFORMATION DO WE COLLECT?

When you use our SITE, we may need to collect certain information from you when use or interact with our SITE (hereinafter referred to as "Information"); we may ask for the following information:

Information you provide to us

- Your e-mail address and country/region when you sign up or log in to your Member Account; if you use your social media account to log in or sign up to a Member Account to use our SITE, any publicly available information (including but not limited to your



profile picture, gender, date of birth and language setting) associated to your social media account may also be collected by us.

- Your name, mailing/shipping/billing address (including zip code), contact information, e-mail address, credit card number or other payment service information when you make a purchase of our devices, paid services or for certain customer service request.
- Your name, mailing/shipping address (including zip code), contact information, e-mail, gender, date of birth and ID number when you enter our events or campaigns.
- Your age, date of birth, gender, height, weight, body temperature, heart rate, blood pressure as well as certain data about your daily activities, for example, your step taken, calories burned and sleep patterns, when you use our healthcare devices or services.

Information from your use of SITE

- Device information: such as your device model, serial number, the version and type of your operation system, IP Address, MAC Address, IMEI number and other unique device identifiers.
- Log information: such as the settings, activation time of your devices, the network you use to connect to our SITE, the status of the network, telephony log information, standby status, crash history, preferred interface, type and language settings of browser, diagnose and usage data as well as your usage behavior on our SITE.
- Location information: such as the version of your devices' GPS and Wi-Fi module, GPS signal, data identifying nearby Wi-Fi access points and cell towers, the time zone and local time where the device is used.

HOW IS YOUR INFORMATION USED?

We use your personal information for three primary reasons:

To whom the Foundation discloses your information

Your information will not be disclosed to any third parties without your consent, other than the following:

Business Partners

We may disclose hashed and anonymized information to our business partners, for example, business partners who provide data analytics services or advertisements and marketing communications based on the hashed and anonymized information.

Service Providers

We may disclose and share your information to our service providers that provide services for or on behalf of us, for instance, service providers assist us with sending marketing communications, providing customer support, delivering purchases and billing. These service providers shall only use your information in compliance with our instruction and with the scope of the purposes hereof; the Foundation ensures that all of our service providers strictly comply with the Privacy Policy.

For legal, protection, security purposes

We may disclose or share your information with third parties for legal or security purposes:

- To the extent it is required by applicable laws or regulations or competent governmental or judicial authorities, necessary to establish or preserve a legal claim or defense, or necessary to prevent fraud or other illegal activities.
- To protect the rights, property or safety of the Foundation, our service providers, customers or the public, as required or permitted by law.

International transfers of your information

You understand and consent to the transfer, storage, use or process of your information to the Foundation and any of its affiliated companies, service providers who may be located in a different country to you. All said transfer, storage, or process of your information, shall be subject to the Privacy Policy and applicable laws on privacy protection and personal information security.

Cookies and Similar Technologies

The Foundation uses cookies and similar technologies to optimize the performance and functionality of our SITE.



Cookies

Cookies are small text files placed on your devices to personalize your user experience on our SITE. Cookies will not collect information that identifies you.

- **Sign-up and authentication:** We use cookies to store your unique sign-up ID number and authentication information on your device. Cookies allow you to visit and move from page to page within our websites without having to log in again on subsequent visits.
- **Storing your preferences and settings:** Cookies maintain your settings and preferences on your devices, such as your preferred language or location; by storing the settings in cookies, it is not a necessity to reapply your preferences and settings each time you visit our websites.
- **Analytics:** We use cookies to count the number and length of your visit on our websites as well as which part or features you visit the most as well.
